REQUEST FOR PRESENTATION

Limited places are available to speak at the renowned CHU SCA (WA) 2022 Convention.

One person working alone can do so little, but together we can impact and achieve bigger results. If you can speak to the Power of Community and are interested in a speaking slot, we encourage you to prepare a submission by 31 August 2022.

We encourage facilitators to focus on their area of expertise or passion with application to the strata industry. Your presentation should be underpinned with the Power of Community theme and offer information of value and education to the strata community.

SUB-THEMES

Session sub theme ideas include:

Leadership

Leadership vs Management - Understand the difference to make you better at both.

Participation

Techniques to persuade people to want to participate.

Culture

Ways to build positive culture in a community, from inclusiveness to building trust.

Relationships

Building relationships and rebuilding fractured ones.

Knowledge

Strategies to share knowledge in a way that fosters engagement, collaboration, and communication.







SELECTION CRITERIA

With only three presentation slots available, it is crucial to ensure your proposal is prepared in accordance to the below criteria to be considered.

Criteria A - Relevance and Importance

The proposal should address topics that are of importance to the broad audience attending and relevant to the Power of Community.

Criteria B - Preparedness

All applicants must have a final presentation ready to present in front of the panel by 12 September 2022. This presentation will form part of the application process.

Criteria C - High Technical Quality

The proposal should meet high standards of technical quality in terms of methodological, conceptual and logical rigor.

OTHER THINGS TO NOTE

Presentation slots are unpaid.

Presentations must be unbranded and on the provided SCA (WA) template.

Selected presenters will be notified on the 22nd of September via email.

All applicants will be required to deliver a run through of their presentation to a small SCA (WA) panel of representatives. The presentation is expected to be finalised prior to delivery, with only minor suggestions from the panelists to be changed.

All presentation timeslots are 20 minutes long, and will be timed during the mock presentation to ensure they fit within the program.

You must be available to present a mock presentation on the 12 September 2022.





HOM TO WRITE AN APPLICATION

TIPS

Think about your audience. Why will this interest them?

Don't use an acronym unless it is well known internationally – especially ones you have made up.

Don't use jargon terms.

Have a colleague read over your work and make sure the sentences are grammatically correct, and there are no errors.

Familiarise yourself with the judging criteria on the previous page.



WRITING AN ABSTRACT

The Abstract is a summary of the content of your presentation. It should be written in an appealing way that provides a 'pitch' for why people should come to your session. Write your abstract as you wish it to appear in the conference booklet and please ensure it is written in third person.

What to include:

- The purpose of your presentation
- An outline of the argument made based on the key concepts of research and strata methods or both
- The main findings and/or conclusions
- The implications for strata practice

WRITING A SHORT BIO

As part of your application, you will be asked for a short biography (no longer then 100 words) so that we can learn more about you. Please include your professional history, including key accomplishments
