Andrew Chambers queried, why is there an Other Income increase to \$50,000 but only an expense of \$39,292? Secretary advised:

- \$30,000 is for external engagement of branding, professionalism promotion of SCA (WA) Accredited Members and SMPS Businesses. Positioning SCA as the voice of strata in the marketplace.
- \$20,000 is for the internal member engagement professionalism, accreditation, and SMPS.

Dyani Cobbold raised that the motion makes no mention of raising a levy nor does the proposed amendment to the motion, so technically it would be raising money without proposing a motion to raise a levy. Also whilst it is allowed under the constitution, should it be after providing only 72 hours notice before the AGM to members?

Chairperson advised only the current motions were being dealt with unless an alternative motion was proposed, if no alternate motion proposed raised comments would be taken on notice.

Marietta Metzger queried if the Other Income increase required was for \$50,000 why did the motion only have an increase of \$30,000 for the Advocacy and Marketing Operating Expenses.

Cherith Pettitt-Jones proposed the amount of \$39,292 in the new amended motion be increased to \$59,292.

Chairperson foreshadows if the motion is not successful the substantive motion stands.

Proposed New Amendment Under Notice:

The proposed budget for 2022-23 (Appendix "C") as provided with the notice of meeting, include an amendment to the Advocacy & Marketing operating expenses from \$9,292 to \$59,292 for professional pathway purposes.
